In 2007 Gerpisa launched its 5th international research programme on "the automobile industry and sustainable development".

In 2011, the characteristics of the post-crisis landscape of the automobile industry remain unclear. The current period is one of industrial transformation of a scale previously unimaginable.

On the one hand, emerging markets have grown significantly and the growth of the Chinese market, in particular, has become of central importance. On the other hand, environmental concerns have successfully highlighted the question of the sustainability of the automobile's continued development if it remains dependent on the internal combustion engine.

If the first automobile revolution was the mass development of the car itself, it is possible that the combination of these two factors will create the stage for a second automobile revolution.

The 19th International Colloquium of Gerpisa gathers in Paris the representatives of the international research and the main actors of the sector in France from the 8th to the 10th of June 2011.

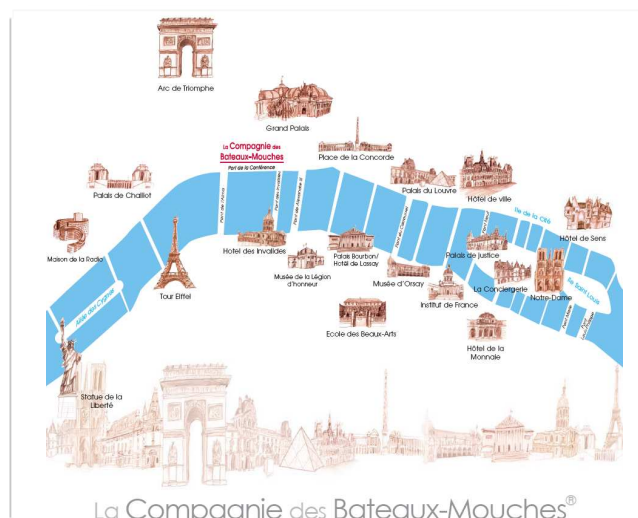
